1. **THIS COURT ORDERS** that the Order of Justice Hailey dated March 4, 2016 be amended as follows:

Paragraph 4(b):

RBC Global Asset Management Inc. shall pay to the Receiver forthwith all funds held in a Non-Registered Investment Account in the name of Revital Druckmann bearing account #409895901;

Paragraph 4(c):

Royal Bank of Canada shall pay to the Receiver forthwith the sum of \$6,233.91 held in account #5172-504-4292 in the name of Revital Druckmann.

2. **THIS COURT ORDERS** that the balance of the Order of Justice Hainey dated March 4, 2016 is in full force and effect.
